Gujarat Energy Development Agency (GEDA) is the State Designated Agency (SDA) for the State of Gujarat under the Energy Conservation Act, 2001. Under the said Act, BEE has suggested some mandatory activities for implementation through SDAs, with the help of certified Energy Auditors & Managers and other Government / Private agencies, so as to effectively implement EC Act, 2001. As per the EC Act, 2001 all Designated Consumers (DCs) have;

- To appoint Energy Managers (EMs) to coordinate and facilitate activities related to Energy Conservation in their premises.
- To get their premises Energy Audited only by certified Energy Auditors (EAs).

One of the activities deals with <u>Conduct of State Level Meet</u> with Certified Energy Auditors and Energy Managers to discuss duties & responsibilities as well as joint progress made by reviewing consolidating progress at individual level. These meets will also help the participant in upgrading their knowledge and skills in latest Energy Management Issue's, Technologies & Solutions through mutual sharing of ideas in their respective area.
